ORDER

WHEREAS, the institution namely Kongunadu Integrated College of Education, S.No.13/4A, 4B, 14/1A, 1B, Puthur East, Marukkalampatty Panchayat, Velagounndampatty, Tiruchencode Taluk, Namakkal-637212, Tamilnadu submitted an online application dt. 02.06.2016 followed by submission of hard copy on 08.06.2016 seeking grant of recognition of B.A. B.Ed./B.Sc. B.Ed. integrated course of four years duration.

AND WHEREAS, the matter was considered by the SRC in its 337th meeting held on 25th -26th April 2017 wherein the Committee decided as under:

1. Their reply is satisfactory.
2. Issue LOI for BA B.Ed. (1unit).
3. Issue LOI for B.Sc. B.Ed. (1 unit).

AND WHEREAS, LOI was issued to the institution on 27.04.2017. The above matter was placed before the SRC in its 387th meeting held on 24th - 25th August 2020. The Committee considered the matter and decided to issue Final show cause notice to the institution to submit the compliance to the conditions mentioned therein.

AND WHEREAS, a Final show cause notice was issued to the institution on 01.09.2020. The institution has submitted its reply on 24.09.2020.

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. On the perusal of the original documents and records submitted by the institution on 24.09.2020 in respect of LoI issued u/s 7(13) of NCTE Regulations, the Committee decided to **grant Recognition to Kongunadu Integrated College of Education, Velagoundampatti (P.O), Namakkal District, Tamilnadu-637212 for conducting B.A.B.Ed. and B.Sc.Ed courses (One unit of 50 students each for both courses) from the academic session 2021-2022 under clause 7(16) of the NCTE Regulations, 2014.**

NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act 1993, the Southern Regional Committee, NCTE hereby grants recognition to **Kongunadu Integrated College of Education, S.No.13/4A, 4B, 14/1A, 1B, Puthur East, Marukkalampatty Panchayat, Velagounndampatty, Tiruchencode Taluk, Namakkal-637212, Tamilnadu for conducting B.A.B.Ed. and B.Sc.Ed courses (One unit of 50 students each for both courses) from the academic sessions 2020-2021 under Clause 7(16) of NCTE (Regulation Norms & Procedure) Regulation, 2014 subject to fulfillment of the following conditions for B.A.B.Ed. and B.Sc.Ed. programmes of two year duration:-**

(a) The institution shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014, as amended from time to time, and ensure the following before commencement of the session:-

- (i) The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
- (ii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of Clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iii) The institution shall comply with condition laid down in clause 8(3) of the NCTE Regulations, 2014, as amended vide Notification on 29.04.2017. which provides as under:-
 - *An institution, which has been recognised by the Council shall obtain accreditation from an accrediting agency identified by the Council within five years of the date of recognition.*
 - *All existing Teacher Education Institutions which have not been accredited so far or have not been accredited within five years from the date of its recognition shall be required to get themselves accredited by the aforesaid accrediting agency within a period of one year from the date of notification of these Regulations.*
 - *The accreditation once obtained shall be valid for a period of five years and the recognised and already accredited Teacher Education Institutions shall be required to get accreditation renewed by the agency identified for the purpose by the Council before the lapse of the earlier accreditation.*

- (iv) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- (v) The Norms for teaching staff in respect of their qualifications and experience shall be as per provisions of NCTE Regulations, 2014, as amended from time to time.

1. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable, and compliance of the following by the affiliating body, State Govt. and also the concerned recognized Institution:-

- (i) **The affiliating body shall be required to verify the authenticity of the land & building documents submitted by the institution, with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 before grant of affiliating to the institution.**
- (ii) **The affiliating body shall ensure that the norms including the norms of Faculty for offering M.Ed. component of the programme as per curriculum of these programme in the University, is scrupulously observed.**

2. The institution shall submit a Self-Appraisal Report to the Regional Committee at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

3. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display as mandatory disclosure the following:-

- (i) Copy of Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition Order
- (v) Information regarding fulfilment of norms & standards and other conditions for the course.

4. In case, if the land is in the name of the Society/Trust, the land is to be transferred within six months from the date of recognition order in the name of the institution, failing which action shall be initiated for withdrawal of recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the Regional Committee along with new land documents within the stipulated time.

5. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by the MHRD.

6. The Institution shall fill the GIS Application within one month from the date of issue of this order.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules and Regulations, the Regional Committee shall withdraw recognition under provisions of Section 17(1) of the NCTE Act, 1993.

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
